

### 2019 USA ARCHERY OKLAHOMA STATE JOAD & INDOOR CHAMPIONSHIP FEB 15-17, 2019

USA Archery Oklahoma presents the 2019 State JOAD and Indoor Championships, hosted at H&H Shooting Sports in Oklahoma City, OK

This will be an official USA Archery/FITA Indoor 600 round (20 ends, 3 arrows per end), using the official 40cm indoor WA/FITA target (choice of single spot or vertical three-spot).

Shooting times (archers will only shoot one line):

- Friday, February 15 @5:00pm
- Saturday, February 16 @9:00am
- Saturday, February 16 @1:00pm
- Sunday, February 17 @9:00am
- Sunday, February 17 @1:00pm

### Archers must check in one hour in advance for equipment inspection.

Registration fee: \$40 payable on day of tournament. Non-competing guest fee is \$25. PayPal option available at website.

Awards ceremony will be held on Sunday, February 17 at 5:00 pm. Certificates will be given to 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place winners in each age, sex, and bow category. **Medals will be mailed to winners following the tournament.**

Dates: February 15-17, 2019 Shooting Times: Friday 5:00p, Saturday/Sunday 9:00a and 1:00p

Location: H&H Shooting Sports, 400 S Vermont, Oklahoma City, OK 73108

Please park in the back parking lot behind the facility

Format: WA/FITA Indoor 600 - 60 arrow round, 20 ends (break at 10 ends), 2 minutes per end

Distance: Yeoman at 9 meters, all other divisions at 18 meters

Target face (FITA):

Yeoman - 60 cm

Bowman/Cub – 60 cm for recurve/barebow, 40 cm for compound, outer 10 ring Cadet/Junior/Senior/Master – 40 cm, inner 10 ring for compound

**Equipment Classes** 

Compound (maximum 60 lbs draw weight)

Recurve

Barebow/Basic Compound (basic compound is a standard Genesis bow, max 20 lbs)

You must be a member of USA Archery. Members of the NFAA may register for a free temporary USA Archery membership on the day of competition.

Competitors for the State Championship must be residents of Oklahoma, or residents of a state that does not have a USA Archery State Organization. Non-residents may compete in a Guest Category for \$25. Medals will not be awarded to the guest category.

Archers may elect to shoot a single spot (60cm/40cm) or a vertical three-spot (40cm only). **Archers may not switch target types.** 

Equipment inspection is mandatory. Please arrive one hour early for inspection.

Concessions are available onsite at the 4U Café on Saturday. H&H Shooting Sports Complex respectfully requests no outside food or drinks on Saturday.

The USA Archery Dress Code will be in effect.
